

**TOWN OF BREMEN  
SELECTMEN'S MEETING MINUTES  
NOVEMBER 5, 2015**

The Selectmen's Meeting was called to order by Chairperson Pieh at 5:00 pm.

Steve Laurich was asked about the Pemaquid Watershed Association's plans for the Weston Spring on Biscay Pond. Steve will check into this.

The Selectmen and Shawn Bennett from All States Materials Group rode some of the Town roads to determine the future course for paving. They discussed a fairly new product called Fog Seal (a liquid asphalt emulsion) used to restore the surface of the roads. The State of Maine has been using this product. It should add 2 to 3 years to the life of the surface of the road. The cost would be approximately \$.70 to \$1.00 per square yard and will seal fine cracks. They also discussed a product called Asphalt-Rubber SAMI which is a stress absorbing membrane type interlayer. This product would be 25% to 30% more than double chipping.

The Storer Road ramp was discussed. The Selectmen will look into the construction of the addition to the ramp.

The letter from AOS 93 regarding picking up high school students was discussed.

***On a motion duly made and seconded, it was voted to speak with the Town Attorney regarding this issue.***

The parking lots and steps to the shore for the Hay property were discussed. The Selectmen will obtain cost estimates for aluminum steps. Town signs for this property and the Town Forest are being made.

The Town of Waldoboro sent out a survey to its residents regarding applying for funds to bring high speed internet broadband accessibility to Waldoboro. Selectman Marsh will contact them to see if Bremen can join in with them.


Selectman Nevins is presently negotiating the snow plow contract and will present his recommendations at the next Selectmen's Meeting.

*On a motion duly made and seconded, it was voted to adjourn at 6:12 pm.*


