*On a motion duly made and seconded, it was voted to create a policy and develop a procedure for accepting Town bids.*


*On a motion duly made and seconded, it was voted unanimously to take Town Clerk Susan Anneley off of her probationary status.*

*On a motion duly made and seconded, it was voted unanimously to adjourn at 6:12 p.m.*


