

**TOWN OF BREMEN
SELECTMEN'S MEETING MINUTES
February 19, 2015**

Selectpersons present: Wendy Pieh, John Marsh, and Henry Nevins
Public: Steve Barnes

On a motion duly made and seconded, the meeting was called to order by Chairperson Pieh at 5:00 p.m.

Steve Barnes was in attendance to discuss a public hearing for Shellfish Ordinance revisions. It was decided to hold a public hearing regarding possible changes to the Shellfish and Traffic Ordinances on March 5.

The road budget for 2015 was briefly discussed. The Town will need an updated plan with estimates in order to move forward.

High-speed internet services for Bremen were discussed. An article featuring Redzone Wireless LLC out of Camden was reviewed.

The invoice from S.B. Nichols for shoreland cutting was reviewed. The Town will hold back \$1,000 for removal of the old boat and shoreland planting in the spring.

The language in the Town Warrant for the Conservation Commission was revised, as they requested.

The discussion on changing the Town's fiscal year was tabled.

The Assessor presented the Selectmen with Supplemental Tax Warrants (2012 – 2014) and Supplemental Tax Certificates (2012 – 2014) for the Munson property.

On a motion duly made and seconded, it was voted to sign the Supplemental Tax Warrants and Supplemental Tax Certificates for the Munson property.

The Selectmen reviewed a newspaper article regarding Redzone Wireless, LLC, an internet company partnering with UMaine to provide high-speed wireless throughout the State. The Town will send a letter of inquiry to Redzone.

The Selectmen discussed the snow that entered the Town Center attic through the rear roof vent. The snow will be removed. Much of the insulation is wet and may need to be replaced. The Town will file a claim with our property and casualty insurance carrier.

There was a brief discussion about a "citizen of the year" program. We presently participate in the Spirit of America Foundation awards and will continue with that.

The Town's recent purchase of 3 FireKing file cabinets from the Changing Seasons Credit Union at a bargain price was discussed. The cabinets sell anywhere from \$2,000 to \$3,000, and the Town purchased them for \$400/each. The Town will make arrangements to pick them up.

The Selectmen were advised that the Town received a credit of \$10.98 from Central Maine Power for a street light outage at Route 32 and Nobleboro Road.


