

**TOWN OF BREMEN
SELECTMEN'S MEETING MINUTES
JUNE 1, 2017**

The meeting was called to order by Chairman Pieh at 5:05 p.m.

Walter Voskian updated the Selectmen on Planning Board activities. At the last Land Use Ordinance Review Meeting on May 24th, there were no substantive changes proposed. The Ordinance will be moved to Public Hearing on July 20th. He advised that the Planning Board has a full agenda for their next meeting.

The Bremen Conservation Commission hosted Representative Mick Devin on May 8th to speak about environmental issues. This event was well attended by the community.

There will be a Public Hearing on June 15th regarding an Extension of the Marijuana Moratorium. The public will be given an opportunity to be heard on this matter.

There was a brief discussion regarding the Clam Ordinance and 2017 clam licenses.

On a motion duly made and seconded, it was voted unanimously to appoint Diantha Robinson and John Mohr, Jr. as members of the Board of Assessment Review.

On a motion duly made and seconded, it was voted unanimously to appoint Kurt Magnusson as an alternate member of the Board of Assessment Review.

On a motion duly made and seconded, it was voted unanimously to accept and execute the 2017 Assessors' Return from the County Commissioner in the amount of \$255,469.52.

Hank Nevins gave a brief update on the Town roads. The salt shed has been pressure washed and then sprayed with waterproofing. This waterproofing will be required again in five years.

Chip sealing of Town roads will tentatively be done during the last two weeks of June. This will include Medomak Road, Creek Road, Town Landing Road, and Collamore Road. Crack sealing will be done prior to that. The Town Center parking lot will also be chip sealed.

The Town House cedar siding has been completed. Exterior painting will be completed as well.

On a motion duly made and seconded, it was voted unanimously to go into Executive Session at 5:30 p.m. pursuant to 1 MRSA §405(6)(E) in regard to a legal matter and also 1 MRSA §405(6)(A) in regard to a personnel matter.



On a motion duly made and seconded, it was voted unanimously to approve the Warrants of 5/26/2017 and 6/02/2017.


On a motion duly made and seconded, it was voted unanimously to adjourn at 6:08 p.m.


