Walter Voskian, Bremen Planning Board Chair, advised that there will be no Planning Board Meeting on June 9. They intend to have a workshop, possibly at the end of June, to discuss updates to the Land Use Ordinance and Building Permit.

There was discussion regarding the Planning Board's request to reduce their quorum to 3 while maintaining a 7-member board. The Selectmen inquired of Maine Municipal Association for guidance on this issue.

Ann Nesslage, Bremen Conservation Commission, indicated the BCC met via zoom. They discussed trail maintenance at the meeting. The condition of the Weston Spring was discussed again.

Sandra Thomas was in attendance to talk about work on Shore Road. She brought a formal Freedom of Access request for road maintenance records. She brought a suggestion for a sign on the road as well as a request for tree removal for better visibility. She requested the Town notify the residents via e-mail prior to any road work.

***On a motion duly made and seconded, it was voted unanimously to appoint the following residents as Election Clerks for July 14, 2020: Bobbi White, Molly Webber, Penelope Card, Elaine Stevens, Janet Dempsey, and Katie Varian.***


The Selectmen briefly went over the Town budget.
