- b. Fireworks Ordinance, this is a suggestion for the beginning of developing an ordinance for the Town of Bremen as to control of fireworks. The intension is to work with the Fire Department and the Ordinance Review Committee to develop some type of ordinance in assisting locating/controlling during drought times.

Selectman Marsh would like to have Chief Teele research with the State of Maine, Fire Marshall Office as to seeing how to handle as to permitting and possible gps location assistance if any.

c. To re-establish a metes and bounds committee that would be charged with the responsibilities

Selectman Papell would like to table this until there can be further discussion with the potential person, Isobel Curtis, as to developing a committee for this purpose and if she would be interested in being in charge of this project due to her expertise.

d. Storer Landing, apply for the necessary permit with the Army Corps of Engineers for the Self Verification to repair and maintain the boat ramp. Steve has prepared a potential scope of work, spoken with Amanda Sayles of US Army Corps of Engineers. At this point the suggestion is to meet with Selectman/Road Commissioner Papell and begin to work on the permitting process.
