Ann Nesslage from the BCC updated that Naomi Martin had been cleaning the bog bridges of ice and snow and hoping that the incoming weather completed that task.



Fire Chief Larry Smith informed the board of a recent meeting with surrounding fire departments and the challenges that all are facing. The discussion based on how to address these challenges and create short- and long-term goals. The group would be called Central Lincoln County Fire District. There would be updates to the mutual aid agreements and potential for centralized stations in the future. This would include towns beginning to utilize trainings together, creating a single tone for the Fire District and in the future, this could include equipment.

On a motion made by Chair Pieh, seconded by Selectman Papell, to accept the warrants of December 10, 11 & 19, 2025. So voted 3-0


On a motion made by Chair Pieh, seconded by Selectman Papell, to accept the minutes December 4, 2025. So voted 3-0


