

**TOWN OF BREMEN
SELECTMEN'S MEETING MINUTES
VIA ZOOM AND IN-PERSON
January 15, 2026 at 5:00 p.m.**

The meeting was called to order at 5:02 pm.

Emily Huber, Lincoln County EMA Director, explained the newly updated Hazard Mitigation Plan and that this plan had been approved by FEMA and LC Commissioners. The plan is to be renewed every 5-years and updates areas of reoccurring problems. Emily also discussed that the plan can be updated during the 5-year term if additional items are found and any current listed item has been resolved. LCRPC can assist with any grant opportunities that pertain to the different areas outlined within the plan, including the dry hydrants that the town/fire dept. is currently looking to address.

Ann Nesslage from the BCC , has met with Brad from Coastal Rivers and discussed that he will be the liaison for the Town now that Joan Ray has retired. Brad informed her that Coastal Rivers is working on goal and how to be more assisting to the town. Ann questioned as to hunting on Coastal Rivers lands, Brad will check and get back to her as to any restrictions or areas that it is not allowed. Ann spoke with Bob Barkalow and the current budget should be fine for the amount of work that is to be completed within. He did go to the Hay Property and there are invasives there, he believes that these can be handled by hand process, that is currently being done in other areas for the town. Discussion of weed whacking around the stones at the Hay Property due to the invasives that are there, this will help in controlling the spread of these through the field and other areas. Ann is also working with Mary Sue Weeks to update the map that she had created; Ann has the cost for printing which will be included in the next budget.

There are currently 5 persons who have contacted the town office in regards to being interested in being on the Comp Plan Committee. If anyone is interested, please send you contact information and any specific field to the town office.

The Town Landing dock repair bid was read by Selectman Papell, this ad will be placed in the LCN for the next two weeks. The bid outlines the dates of when bids need to be received by and opened: receive by 2:00 pm on Thursday, February 19th and opened that day at 5:30 pm at the Selectmen's meeting.

Resident Hank Nevins questioned as to the land sold to the library and nothing being done, any update. Ann Nesslage responded that the deck is the first stage that the library received a grant for. The library is now overseeing the property and not the previous committee.

So voted 3-0




