14. Any changes in project as submitted require CEO approval.
15. Any proposed dwelling requires an approved sewage disposal system.
16. A Certificate of Occupancy is required BEFORE any structure may be inhabited or used.

**False information may invalidate a permit and require that work be stopped. Your signature authorizes inspections necessary to issue permit and ensure compliance with regulations.*

**All plumbing must have approval of the Bremen Plumbing Inspector. Building permit applications submitted for either a mobile home or modular home must be accompanied by an internal plumbing permit.*

**I certify that if this permit is granted, I will conform to the provisions of all ordinances of the Town of Bremen, the Maine Uniform Building Code (MUBEC), and the National Fire Safety Association (NFPA) Life Safety Code 101.*

**The building inspector will be notified when the work is ready for required inspection(s). This structure shall not be occupied until a certificate of occupancy has been issued.
