Easements for the different town owned properties, there are easements in place for Weston Spring and the Hay Property. There will be more bog bridging on HiltonO'Connor trail. The Save Our Tree discussion will happen on July 15th and the committee discussed having another discussion later in regards to property owner use of easements. There has been positive response to the septic brochure that was inserted in the annual Town Report.

Cheryl Ferrara gave an update on the Comprehensive Plan Committee; the committee is looking to increase the community input. This being achieved by using a survey then using different events, canvassing and having this available at different events. Cheryl met with Emily Rabbe in regards to LCRPC doing the work on the transportation portion for the updated Comprehensive Plan. Emily also said that the committee should be creating an inventory of what we know, not trying to solve problems that is thought to

exist. This inventory is then used to update the current Comp Plan from 2004. The Committee meets the last Thursday of the month and the public is welcome and encouraged to attend. The meetings are held here at the Town Center and begin at 6:00pm.

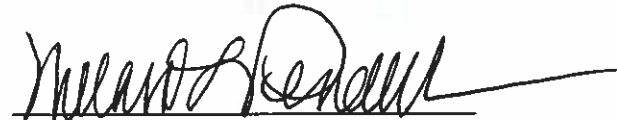
On a motion made by Chair Pieh, seconded by Selectman Papell to accept the warrants of May 22, 2026 and June 5, 2026.

On a motion made by Selectman Papell, seconded by Selectman Marsh to accept the minutes of May 21, 2026.

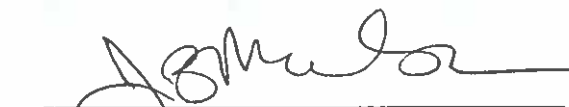
So voted 3-0
